Plans for the 64th annual meeting of the Midwest Chapter of the Music Library Association in Lexington, Kentucky are well underway. We hope to see many of you here in the Bluegrass October 20-22 at the University of Kentucky.

The Hyatt Regency, located in downtown Lexington, is our conference hotel. As part of the Lexington Convention Center complex, which also includes Rupp Arena and the Civic Center Shops, the Hyatt is ideally suited for shopping, eating, entertainment, and, of course, meetings. The University of Kentucky campus is within walking distance. The Hyatt has graciously provided a website for you to book your hotel room as a conference attendee. Following the usual committee meetings in the afternoon, we will open our program Thursday evening with a trip to the Lexington Public Library, located just a few blocks from the hotel. After a welcome and introduction to the library from the director of the Lexington Public Library system, we will then be treated to a session on shape-note tune books and a "mini-sing"—so start warming up those vocal cords now! Our opening reception will be held in the library's rotunda, which contains the world's largest ceiling clock, a five-story Foucault pendulum, and a frieze depicting the history of the horse in the Bluegrass.

On Friday we will journey to the University of Kentucky campus. (Transportation will be provided from the hotel to campus.) We will begin the day at the William T. Young Library with some social time over breakfast provided by the UK Libraries. Following a welcome from the Dean of Libraries and the Director of the School of Music, we will begin our program that will include a session called "Oddball Questions and Secret Sources."

A nice walk through campus (don't forget your walking shoes!) will bring us to our luncheon destination in the newly refurbished Main Building, the campus' main administration building. After lunch, you will have a choice of tours of several of our unique campus offerings—the William T. Young Library, the UK Art Museum, the Lucille C. Little Fine Arts Library, and the King Library Press.

On Friday evening we hope everyone will enjoy an Old Kentucky Night at the Kentucky Horse Park. Activities will include a hayride, open grounds and horse barns, a clogging performance, and a buffet dinner featuring burgoo, pulled pork barbeque, and pecan pie. Dress for this should be casual—think horses, barns, and hayrides!

We will conclude our meeting on Saturday morning at the Hyatt Regency with our annual business meeting and a session on working in and using overseas libraries.

For those who wish to stick around after the conclusion of the meeting, there are a number of places to visit and things to do in the Lexington area. A highlight of Lexington in October is racing at the Keeneland Race track. Enjoy the historic track, place a few bets, and cheer on your favorite horses. Other sites include Shakertown, the Henry Clay estate, many museums, and much more. Links for many of these attractions are included in the local arrangements information in this newsletter.

Clear your calendars and "Come on-a my house" the third week of October and join us for a few days of music, libraries, and fun—Kentucky style!

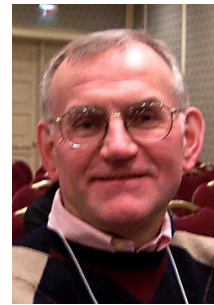

### **HYATT REGENCY HOTEL**

Our conference hotel is the Hyatt Regency, located at 401 High Street at South Broadway in downtown Lexington. It is part of the Lexington Convention Center complex, which also includes Rupp Arena and the Civic Center shops.

The Hyatt has graciously provided a website for you to book your room as a conference attendee (URL below). The conference room rate is \$95 per night plus 13.4% tax. **Please make your reservation by September 19!** October is a busy month for horse racing and hotels fill quickly, so you are urged to make this deadline, or rooms may not be available.

### **TRAVELING BY AIR**

Lexington's Bluegrass Airport (LEX) is served by American Eagle, Continental Express, Delta Air Lines, Northwest AirlinK, United Express and US Airways Express. The Hyatt provides a courtesy van from the airport from 5 a.m. to midnight. A courtesy phone to the hotel is located in the baggage claim. A taxi ride from the airport to the Hyatt should be in the range of \$15-20.

### **DRIVING AND PARKING**

#### **Bluegrass Airport to Hyatt Regency**

From Bluegrass Airport, turn left onto Man o' War Blvd. At the first traffic light turn right onto U.S. 60 East (Versailles Rd.) and follow signs into downtown Lexington. Versailles Rd. turns into Maxwell Street. Turn left onto South Broadway at the first traffic light. The hotel is on the corner of High Street and South Broadway. Turn left onto High and the hotel is on the right, parking on left. (High is one-way.)

#### **I-64 East or I-75 South to Hyatt Regency**

I-64 East and I-75 South merge just north of Lexington; exit numbers follow I-75 mile

markers. After the highways merge, take exit 113 and turn right onto Paris Pike/U.S. 68/U.S. 27 towards downtown Lexington. See below for further directions to hotel.

#### **I-64 West or I-75 North to Hyatt Regency**

I-64 West and I-75 North merge into one highway just east of Lexington; exit numbers follow I-75 mile markers. After the highways merge, take exit 113 and turn left onto Paris Pike/U.S. 68/U.S. 27 towards downtown Lexington. See below for further directions to hotel.

#### **Further directions to hotel from I-64 or I-75**

Paris Pike/U.S. 68/U.S. 27 will cross New Circle Road (Route 4) and continue into downtown, eventually becoming North Broadway. As you get into downtown you will pass through the campus of Transylvania University and by the Lexington Opera House on the right. Just after the Opera House you will cross Main Street and pass by Triangle Park on the right with the convention center behind it. North Broadway becomes South Broadway when you cross Main Street. The Hyatt Regency is on the corner of High Street and South Broadway, just past Triangle Park. Turn right onto High Street and hotel is on the right, parking on the left. (High Street is one-way.)

#### **From Hyatt Regency to University of Kentucky Campus (Friday morning)**

NOTE: The Local Arrangements committee is making every effort to provide transportation from the hotel to campus for Friday's meeting. Parking is very difficult on campus and you are strongly encouraged not to drive and park. If you need to drive for any reason, contact Paula Hickner or Kerri Scannell prior to coming to Lexington for assistance with parking so arrangements can be made.

From the front of the Hyatt, turn onto High Street (one-way), pass Rupp Arena on the right and turn left onto Madison Place (if you see Cox Street on your right, you've gone too far). When Madison Place ends, turn left onto Maxwell Street. Maxwell is also a one-way street. Stay on Maxwell through 3 or 4 lights until you get to Rose Street (you'll start seeing campus buildings on your right). At the light at Rose Street turn right onto Rose. Once on Rose, turn left at the second light onto Columbia Avenue. Turn right at the next light onto Woodland Avenue and follow the road as it turns to the right again and becomes Hilltop Avenue. Visitor parking for the William T. Young Library is on the right. Parking is \$8 a day.

## **WALKING TO LPL AND UK CAMPUS**

### ***From Hyatt Regency to Lexington Public Library (Thursday evening)***

Leaving the Hyatt, turn left towards South Broadway. Turn left at the corner onto South Broadway and walk down the road toward Triangle Park. Walk two blocks to the corner of Main Street and South Broadway and turn right onto Main Street. Walk three blocks past the Radisson, the Old Courthouse, and at the fourth block you'll see another little park on the right and the new courthouses on the left. The Lexington Public Library is on the right, next to Phoenix Park in a five-story dark granite/limestone building.

NOTE: Lexington is full of one-way streets and streets that constantly change names (usually when they cross Main Street or some other imaginary line). If you have to drive to the Public Library on Thursday evening, there is a parking garage at the library, but it may take you longer to drive than to walk. Contact Paula Hickner or Kerri Scannell for specific driving directions to the Public Library and its garage.

### ***From Hyatt Regency to University of Kentucky Campus (Friday morning)***

October weather is often nice in Lexington and conference attendees may choose to skip the bus and walk to campus. For those who wish to walk, plan on 20-30 minutes. From the front of the hotel, turn left and cross South Broadway, staying on High Street. High Street is one-way and you'll be walking against the flow of traffic. Walk about three blocks and turn right down South Limestone. Again, this is a one-way street and you'll be going against the flow of traffic. When you reach Maxwell Street (one long block), turn left, cross Maxwell here if possible or wait until farther down the road. Head down Maxwell Street for about four blocks to Rose Street. Turn right onto Rose and walk all the way up Rose into campus. Turn left onto Columbia Avenue and you'll see the William T. Young Library farther down on your right.
